## Basic Job Description:

**Summary:** This position's primary responsibility is to provide exceptional customer service by greeting and assisting customers with their purchases. Must maintain the cash register with integrity and accuracy and ensure the register area, fitting rooms and sales floor are kept neat, clean, organized and replenished.

#### **Essential Duties and Responsibilities:**

- 1. Warmly greet and treat all customers with respect, fostering an exceptional shopping experience.
- 2. Maintain cash register with integrity and accuracy at all times.
- 3. Answer phones and make store announcements in a professional and courteous manner.
- 4. Maintain appearance of the store by cleaning, organizing and replenishing the sales floor as needed.
- 5. Ensure that goods are properly sorted, priced, and staged for sale in a timely manner.
- 6. Replenish sales floor; put out racks of clothing following all sizing and color guidelines in a timely manner.
- 7. Perform other duties assigned by store managers and supervisors.

#### **Core Attributes and Expectations:**

- 1. Display a Christ-centered life demonstrated by a willingness to show acceptance and serve others.
- 2. Work efficiently and manage time in order to meet production needs as well as other assigned tasks.
- 3. Show motivation and ability to take initiative in daily tasks and operations.
- 4. Exhibit good work habits in attendance and punctuality.
- 5. Treat customers and co-workers in a kind, respectful, and professional manner.
- 6. Show respect for the integrity of the work place through honesty and responsibility.
- 7. Demonstrate a willingness to learn and an openness to new ideas and changes.
- 8. Follow all safety guidelines.

- 3. Organized: Strong ability to multi-task between customer excellence, product placement and maintaining a neat, clean and organized work space and sales floor focus
- 4. Self-Motivated: Develop skills and abilities to become more proficient and efficient in merchandise placement, reaching and exceeding daily goals and delighting our customer.

- 1. Have the ability to work on one's feet for an entire shift and move with a sense of urgency.
- 2. Lift and move 10-20 pound bags of donations on a regular basis.
- 3. Manipulate tagging guns and staplers in a repetitive manner.

  - Live free of sexual sin (to include pornographic materials, homosexual conduct, and extra-marital relationships).
  - Respect the sanctity of life from conception until death in God's timing.
