MIRACLE HILL PARTNERS WITH LOCAL AGENCIES FOR GED AND EMPLOYMENT TRAINING AND OFFERS A POST-GRADUATION RESIDENTIAL TRANSITION PROGRAM WITH ASSIGNED MENTORS TO HELP EQUIP GRADUATES FOR SUSTAINED SUCCESS. OUR RECOVERY PROGRAMS SERVED 485 INDIVIDUALS LAST YEAR, PROVIDING 55,262 DAYS OF COMPREHENSIVE CARE AND COUNSELING. 111 INDIVIDUALS GRADUATED. OUR LONG-TERM SUCCESS RATE FOR GRADUATES IS 60%.
